Changes — estimated time 1 hr.

- My Funds page column with rating change "Would Suggest" to "Would Recommend"
- Shrink columns, such as Approx AUM (8 characters)
- Approx AUM should format to \$mm
- Fund count not updating
- Refresh value list for names
- When sending email to all allocators, BCC emails

New Requests — estimated time 7-10 hours

- Add check "select all" on user list for email
- Add Show All in navigation scripts
- Add User Detail page to FileMaker
- Add username to view on FileMaker
- When a user "deletes" a fund from "My Funds" move to different section and show only fund name
- Change Activate and Read Only checkboxes to one or the other, not both
- Log emails between users (sent and received) and create display pages
- Filter out duplicate emails for connection emails (user already had "want more information" checked, new user checks "willing to share")
- Sort by columns on list views

Ask Joe — estimated time 1 hr.

- Auto log out after 15 minutes of inactivity
- When Milton deactivates a user, lock the site
- Ask Joe about formatting text from FM fields to WP (such as font, bold, italics, etc.)
